Thank you for your request for information of 5th November 2020 which has been processed under the terms of the Freedom of Information (Scotland) Act 2002. Unfortunately, Cloch Housing Association is only able to meet part of your request. The information you asked for namely, 17 questions with regard to our spend on PPE, is released to you now in the format requested as per the below, where we hold the information.

Appealing to the Commissioner

You must submit your complaint to the Commissioner within 6 months of receiving our review response.
